(e) Detailed list of Doctors, Nurses and staff along with their qualification (with proof), complete residential address, salary paid / payable during the year, TDS made, PF and Professional Tax deducted with evidence for the last 3 years.

(iii) Year-wise details of donations with full name, address, PAN of donors, date and mode of donation,

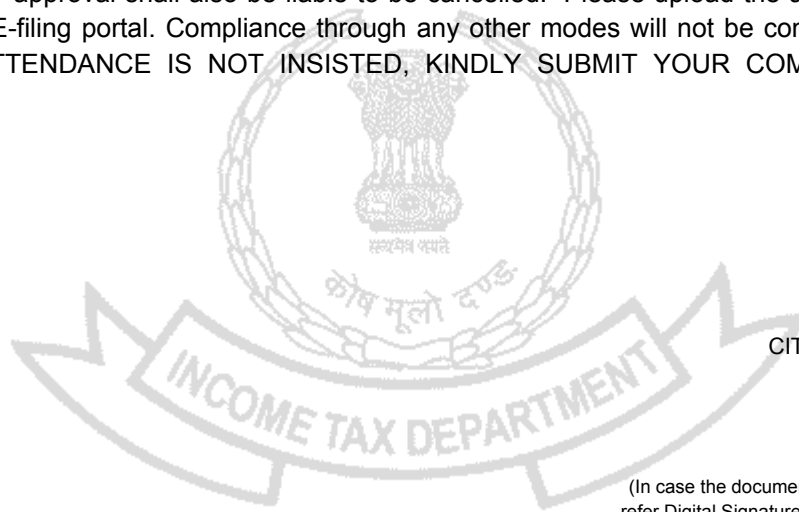
(iv) No supporting evidence viz bills/invoices of expenditure on each activity, photographs, cuttings etc has been furnished to prove the genuineness of activities.
